If there is no profit to be had from the game in question, then the chapter shall cover the Society fee. This policy does not apply to anyone who was a NPC but also played a player character and received either experience or treasure in the same game day. This policy will be enacted for a trial period through January 31, 2020. At which point the Board will revisit the policy."
