## **GM'ing Tips**

1) Be unobtrusive when not needed. Let the PCs focus on the NPCs.

2) Be handy when PCs want answers to Informational abilities or just have questions. (a delicate balance with #1)

3) Get the attention of most of the PCs at the start of encounters to be sure they hear the encounter description. It's particularly important when the game has some encounters that are tricky to figure out. Once you've set the stage, refer back to #1 and #2. For some encounters, you don't need to say anything.

4) Keep track of how the team is doing physically, SP, HP, the works. It's ok for the team to have a challenge, and even get someone knocked out, but unless the game is a high risk one, we don't want to kill off any PCs and especially not a whole team - ESPECIALLY for a novice game. If they are just getting pounded by an encounter because they just aren't doing the right thing, sometimes the GM can give an unscripted hint to get them to try something different. And if they try something that's not in the script but seems like it should work, the GM has the authority to decide it worked.

5) Doesn't hurt for the GM to make sure they drink water now and then without being too pushy and encourage them to stay warm and eat a snack if production causes a delay.

That's a random assortment of thoughts for GMing that come to mind this evening.

The Flat Rate CAP Awards, table 5-2 above, are fixed-rate amounts based on a full year of service. If a member resigns or leaves their position on a board or a committee, then they will only receive a portion of the reward prorated to 1/12th of the total eligible CAP amount per actual month served.

Table 5-3 shows that non-board members attending any Board Meeting, at either the society or the chapter level, shall receive 3000 CAP per meeting attended up to a maximum of 15,000 CAP per person per year.

The maximum amount of TOTAL Administrativer, or Non-Game CAP that can be awarded per person per year is 200,000 CAP.

The President/Chair/Editor will submit at the end of their year term, the special CAP earned by themselves, their members and any others that participated in committee activities, once a year to the appropriate Chapter Registry chair, including any outside "special projects" assigned. The reporting of this CAP will be completed by using either "pink sheets" or direct email to the Registry Chair, no matter what the method the member shall be notified at the same time of the amount of CAP earn through their committee work for the year. The reporting shall be completed within 30 days of the end of the committee term.

## Administrative, or Non-Game CAP Cont'd

Yearly CAP awards for non-game related work, tasks, assignments or events, shall be made public for the membership at large as an itemized list of each member's activity. This shall be done through all available methods of communication available, such as; the society/chapter newsletter, forums and/or email. Communication of this information shall go through the communication resource that will inform the largest number of people. Accountability to the membership is of the highest priority in this matter.

#### The basic rule is that if a person works on an official IFGS event that runs, then they get CAP.

People who claim CAP for a game, but that do not attend the game, must have those claims validated with the Game Producer and/or the creative staff. All claims with merit will be awarded the appropriate CAP. This situation is most likely to arise with the Game Writer or members of the Game Sanctioning Committee, but it might come up with other members of the production staff.
